Brothers,

As we approach the beginning of the second year of the Civil War sesquicentennial, I'd like to thank you for your efforts this past year. Our Order is doing exactly what it should be doing: supporting commemorative events in our communities and keeping alive the memory of the "Boys in Blue".

Nothing catches the public eye better than our members in uniform. I believe this is an area we can all do a little better in. Here are a few recommendations:

a) Prepare for an event 2 or 3 days in advance by going through your "kit" to make sure you have everything you need.

- b) Make sure your uniform is clean and do your best to have it fit well. Consider alterations if it's too loose and get new items if some are too short or fit too tightly.
- c) Follow the uniform standard for your unit. If your unit doesn't have a standard, consider establishing one. Have all members uniformed alike at events same style coat, cap, belt buckle, etc
- d) Make sure your brass is polished and leathers are blackened. Bring boot and brass polish and spare uniform items to events to address last minute corrections.

# Drill and Ceremony: Command's

# FROM CASEY'S INFANTRY TACTICS COMMANDS

There are three kinds.

- **69.** The command of *caution*, which is *attention*.
- <u>70</u>. The *preparatory command,* which indicates the movement which is to be executed.
- <u>71</u>. The command of *execution*, such as *march* or *halt*, or in the manual of arms, the part of command which causes an execution.
- <u>72</u>. The tone of command distinct, and of a loudness should be animated, proportioned to the number of men under instruction.
- <u>73</u>. The command *attention* is pronounced at the top of the voice, dwelling on the last syllable.

- <u>74.</u> The command of *execution* will be pronounced in a tone firm and brief.
- <u>75</u>. The commands of caution and the preparatory commands are herein distinguished by *italic*, those of execution by CAPITALS.
- <u>76</u>. Those preparatory commands which, from their length, are difficult to be pronounced at once, must be divided into two or three parts, with an ascending progression in the tone of command, but always in such a manner that the tone of execution may be more energetic and elevated; the divisions are indicated by a hyphen. The parts of commands which are placed in a parenthesis, are not pronounced.
